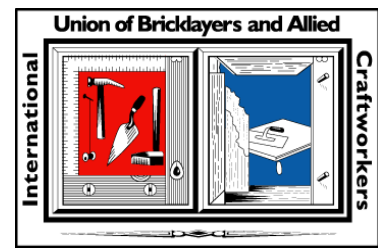

This is to advise you that the new working agreement calls for a wage increase of \$1.00 per hour on May 1, 2007. Please inform your bookkeeping department of the following rates.

The total wage rate effective May 1, 2008 for members of the Bricklayers and Allied Craftworkers in the Minot, North Dakota area will be as follows:

Base Rate: \$24.48  
 Vacation, Dues Check Off: \$1.68

If you need a copy of the current contract, please feel free to call the Union office.

**Bricklayer Foreman** shall receive an additional 10% per hour above the taxable rate - \$2.62.

**Residential Rate** – The base wage for Journeyman shall be \$.50 lower than the rate listed above. The rate for Apprentices shall be \$.50 lower than the rates listed below. All fringe benefits shall remain the same.

**Height Pay Rate** - Any work over **50 feet** in height shall be paid \$1.00 per hour over scale. For each additional 50 feet of height \$.50 per hour will be added to the hourly rate.

**Per Diem** – 35-50 miles from home will be \$30.00, over 50-100 miles from home will be \$45.00, and over 100 miles from home will be \$70.00. Mileage is calculated from the Post Office of **Employer's** hometown to the job. The towns of Bismarck, Minot or Dickinson nearest to the **Employer's** main office will be considered their hometown.

5th 1000 hours 85% - \$20.81	\$22.49 *
6th 1000 hours 95% - \$23.26	\$24.94 *
