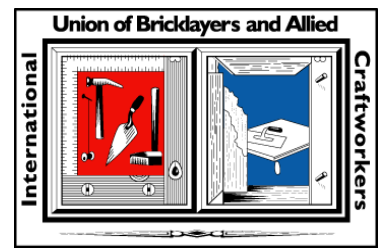

**SWING PAY** – There will be no premium pay for Swing Scaffold work.

**PARKING** – Employees shall be reimbursed \$6.50 per day when paid parking is required.
