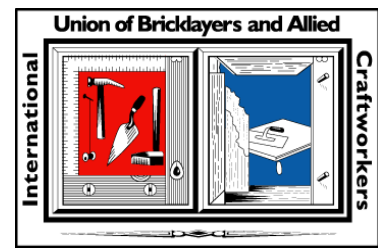

1st 1000 hours 50% - \$14.13	\$16.60 *
2nd 1000 hours 55% - \$15.54	\$18.01 *
3rd 1000 hours 65% - \$18.36	\$20.83 *
4th 1000 hours 75% - \$21.19	\$23.66 *
5th 1000 hours 85% - \$24.01	\$26.48 *
6th 1000 hours 95% - \$26.84	\$29.31 *
