On Sat., May 6, 2023, 22 top apprentices in brick, tile, and PCC came together at the Training Center to compete in our annual contest of skill for notoriety and top prizes. First-place winners received \$900 in prizes and gift cards, second-place winners received \$350 in prizes and gift cards, and third-place winners received \$200 in prizes and gift cards.

Each competing apprentice was selected by scoring the highest in their class on a timed project evaluation. The contest project builds are also timed and must be completed within four hours. All the brick apprentices were provided with a drawing of a block and brick project, specific to their year of training, that they had to lay out and build. The PCC apprentices demonstrated their skill in tuckpointing, tooling, caulking, flashing, Jahn patching, and in-filling a brick project. The tile apprentices were provided a drawing of a two-wall shower stall where they had to mud a shower pan, plan and lay out their cuts and pattern, and set the floor and walls.

The annual apprentice contest is an opportunity to recognize and award our outstanding apprentices for their efforts in honing their crafts. We couldn't put this contest on without the help of our volunteers and sponsors. Relieve Your Teary, Allergy Eyes

- Wear wrap-around glasses or sunglasses to keep pollen out of your eyes.
- Place a cold compress over your eyes to soothe discomfort.
- Use artificial tears or lubricating eye drops to flush out any irritants.
- Try an over the counter remedy like allergy eye drops, oral antihistamines, or other medication for mild allergies.

Did you know?

Contact lens wearers should wait at least 15 minutes after using any allergy eye drops before putting in lenses.



Apprenticeship training is vital to our trades' and union's continued success. Each of our apprentices spends 144 hours per training year with us at the training center—they must also complete between 4,000 and 6,000 hours of on-the-job training under the guidance and supervision of fellow journey-workers before journeying out. These first few years of their careers are full of learning opportunities, growth, and challenges, all of which are no small feat. Pre-apprenticeship: What It Is and Why We Do It

Recruiting new apprentices for our trades has its challenges: the ebb and flow of the peak and slower seasons, the environment, and the work itself. We get interested individuals inquiring about working in our trades year-round. However, the reality of getting someone with no experience a job in the middle of winter is that it's nearly impossible. We try to keep people interested and encourage them to attend one of the preapprenticeships we offer in the spring and summer.

We're in the fourth week of our spring brick preapprenticeship. We've taken 16 interested individuals and immersed them in masonry. When they complete their six weeks of training, they'll have essential experience in various tasks preparing them for a summer of work before they begin their related training. Some of it is the simple stuff, like showing up to the training center before 7 am so they're prepared to start work right at seven, and some of it is a little more intimidating, like using a saw to cut brick and block. We believe that this brief training makes a new apprentice more valuable to their crew and, thus, the potential to be more successful in our trade.





REGIONAL UPDATE

IMI Masonry Minute

KEY IMI ACTIVITY HIGHLIGHTS

Minnesota IMI Director Mark Swanson promotes the use of masonry and skilled union craftworkers, and provides masonry education and consulting to the design and construction community. His main goal is to create more work opportunities for signatory contractors and members of BAC Local 1 MN/ND/SD.

STRUCTURAL MASONRY COALITION


Sam Rubenzer, IMI's consulting structural engineer, has been busy this year. He provides guidance to our local engineers and signatory contractors. This is a value add for belonging to the BAC union. Rubenzer continues to emphasize the value of designing efficiently with structural masonry.

- Signatory Contractor Support Rubenzer recently provided structural masonry redesign support guidance to a Northern MN signatory contractor to assist them in offering a masonry alternate that has the potential of generating more work opportunities for them.
- **MBJ Engineers** He has been assisting MBJ engineers from Rochester to design full masonry lintels on the West Delaware School project.
- HGA Rubenzer provided guidance to HGA's structural department on a recent project.
- AST Engineers He had recent conversations with AST engineers on an in-place masonry wall in field mortar tests using C780 on an undisclosed project.

PROJECT SUPPORT

- Locus Architecture, Minneapolis, MN Provided guidance on brick matching for an undisclosed addition.
- HGA Architects, Minneapolis, MN Provided guidance to the architect participating in Boston Valley's ACAW program.
- **SOM, NYC** Swanson worked with IMI's NYC Director Alan Feltoon, to provide guidance on a new private school project with custom glazed brick shapes and patterns.
- **BWBR Architects, St. Paul, MN** 1932 State Office Building near State Capital, interior granite panel renovation. Interior courtyard walls are to match the exterior granite. It's early in the design and the guidance was to replicate with a dimensioned anchored stone, but they were exploring adhered solutions as well.

- LHB Architects, Minneapolis, MN This effort is taking shape with the BAC/IMI/IMTEF team for providing terra cotta repair and attachment support, guidance and training to the contractor and the design team for a specific project in Minneapolis. Credit goes to Darrel Koffler working with Dominionaire, who reached out to the BAC Training Center Director John Slama, to ask about IMI/IMTEF support for his crew on this project. Koffler and Slama got the response ball rolling.
- Ryan Companies, Minneapolis Provided guidance on an adhered veneer project. Considering the climate in the Midwest region, IMI suggests the use of a moisture control system, such as a drainage mat, for adhered veneers. However, in arid climates with limited rainfall, where excessive moisture and freeze-thaw cycles are not a concern, installation of drainage mats may or may not be necessary.



IMI EDUCATION AND PROGRAMS

- IMI National Structural Coalition Webinar Series, February 1 – Swanson hosted Sam Rubenzer of Forse Consulting to present to more than 600 attendees "Structural Fundamentals: Masonry Movement Joints." Local MN firms included ISG, BKV Group, Northland Consulting Engineers, and LHB attended.
- IMI MN/ND/SD Masonry Wednesday Webinar Series, February 15 – Todd Kimmel presented on the Passive House Primer on behalf of the Building Energy Exchange. Passive House is a green building standard similar to LEED or Green Globes. The main goal of Passive House is to create highly

energy-efficient buildings that require very little energy for heating and cooling. The Passive House standard is a rigorous set of criteria for building design and construction that results in buildings with excellent thermal insulation, airtightness, and ventilation.

- IMI National Structural Coalition Webinar Series, March 1 – Swanson hosted Brady Galinski of Forse Consulting to discuss the design of Tornado Storm Shelters using masonry to 350 architects, engineers, contractors, and owner groups, like the State of Minnesota, University of Illinois, and Nashville Public Schools.
- IMI MN/ND/SD Masonry Wednesday Webinar Series, March 15 – Swanson and IMI Director Scott Conwell, delivered a tile webinar called "Ceramic Tile's Role in Reducing Carbon and Building Green" to a variety of attendees including KH Engineering, the University of Minnesota, and our own BAC Training instructor Mike Churilla.
- IMI National Structural Coalition Webinar Series, April
 5 Swanson hosted Rubenzer who presented "Sustainable Structural Masonry Strategies" to more than 320 architects, engineers, and owner groups like the University of Minnesota. Rubenzer discussed tips on how to design with masonry to address energy efficiency, carbon neutrality, resiliency strategies, and more. A frequent message on the series is that efficiently designed masonry wall systems can lower a project's embodied carbon without having to jump through hoops.
- IMI MN/ND/SD Masonry Wednesday Webinar Series, April 19 – Swanson kept the focus on Structural Masonry for the regional audience when he hosted Rubenzer to discuss low carbon solutions with masonry and the SE2050 Challenge.



ACE MENTOR PROGRAM

Since October 2022, Swanson has mentored Edina High School ACE students as they competed to design the school of the future on the old Sears site by the MN State Capital in St. Paul. ACE stands for Architecture,



Construction and Engineering. In April the Edina team presented at the University of Minnesota against other Twin City ACE teams and walked away with first place! Other mentors on the Edina team were from Mortenson, Kraus Anderson, Ryan Companies, and led by Dustin Rehkamp, an architect with Leo A Daly. During the last few years, Swanson has been an ACE mentor at Shakopee, Humboldt, Minneapolis Hub, St. Paul Hub, North St. Paul and Edina high schools.

CODE CHANGES THAT COULD HELP IMPROVE STRUCTURAL MASONRY

IMI continues to work with The Masonry Society (TMS) on code provisions to improve the efficiency of reinforcement installation in structural masonry. Truss-type horizontal joint reinforcement is commonly specified in structural masonry walls, but causes issues with placement of vertical reinforcement within the wall. Vertical reinforcing bars are specified to be centered, but are either shifted to avoid interference with the diagonal cross wires or those diagonal wires are cut for the vertical bars to pass

> through. Current masonry code discourages the engineer from using truss-type reinforcement in walls with vertical reinforcement, but designers continue to specify it. Currently, IMI is working with masonry code committees to prohibit the use of truss-type joint reinforcement in masonry where vertical reinforcement is present. Doing so would help make both the design and installation of structural masonry more efficient, while reducing quality control issues and creating fewer mortar droppings from the cross web of truss reinforcement. These small

improvements can make a big impact in structural masonry's desirability for the industry at large.

2023 IMI MASONRY CAMP

Swanson played an integral role in 2023 Masonry Camp in March. This weeklong experience pairs young architects with apprentices to collaborate and learn from each other. The architects provide their design expertise, and the apprentices share their craftworker skill sets with the architects. Final design-build projects were judged by Camilo Garcia of DPR Construction, Eric Oskey, a winner of the JBC Innovation in Masonry award, President Tim Driscoll and IMTEF Director Tony DiPerna. The next camp is in 2025.
