# **Taking Action on Financial Education for Apprentices and Journeyworkers**

How many frightening stories and statistics do we need to read before we do something to prevent financial failure? That question was asked and answered at the 2016 Institute for Apprenticeship Training and Education Programs, sponsored by the International Foundation of Employee Benefit Plans (IFEBP). There was a session called "Developments in Financial Literacy," and the speakers provided examples and tips on how to bring financial education back home to apprentices and journeyworkers. Typically, a financial "horror story" is based on a lack of understanding, which can be addressed by providing members and their families the opportunity to learn.

Lately, the IFEBP has empasized the need to address the increasing demand for financial education, particularly in the area of retirement security. Union leaders, employers and trustees agree that a better educated work force is best when it comes to productivity, and financial education has become an important part of the curriculum.

In recognizing "money stress" as an important employee concern, the American Psychology Association surveyed the U.S. workers on the degree of stress caused by financial concerns. Seventy five percent of all workers surveyed feel stressed out about money some of the time. Twenty five percent feel stressed out about money ALL of the time. The survey shows how financial stress has a direct negative impact on employee productivity.

The MN and ND Bricklayers and Allied Craftworkers Journeyman and Apprentice Training Trust Fund has hosted and will continue to host presentations at its New Hope Training Center for apprentices and journeyworkers. There are resources available to Local 1 members to address specific financial questions or concerns.

Take the initiative to learn more about your finances. Ask your union representative, apprenticeship coordinator or instructor on ways you can improve your financial literacy. You won't regret it.

#### FROM THE PRESIDENT

### **Successful Move to HealthPartners**

Our transition is now complete to Health Partners as our Preferred Provider Organization (PPO) for medical care. For medical care received after Jan. 1, 2016, for our active members and early retirees Health Partners provides both the medical network of health care providers (PPO), and the processing of your claims for payment. I strongly urge you to explore the new tools available to you through the Health Partners website or smart phone app. You

will find a vast array of tools available to you to help you find the best resources for your medical situation and location. You still may go outside the network for health care, however everyone's best financial deal is offered through our PPO providers.

This was a complete project. We are now ready to provide the best-in-class services to members, while capturing the data needed to help us focus our future efforts. The Board of Trustees of the Health Plan is hopeful that our new relationship with Health Partners will bring us closer to several goals:

- 1. Stabilize health care premiums;
- 2. Keep more members and their families insured more often;
- 3. Stabilize fund reserves;
- 4. Launch long term programs to promote health and wellness.

Our Budget. We remain a self-insured Taft-Hartley Fund. The money we collect from employer contributions, along with any earning on our investments, is what we have to spend on paying for care and administering our Fund. Internally, the Fund accounts for what members have in the HRA's. We also internally account for the cost of your pre-funded retiree health care benefit, which is a substantial cost and a great benefit to members. The board's actuary forecasts claims costs for services where the bill has not yet arrived (call incurred but not reported, or IBNR). After a review of thee various components, the board is able to measure what is left in the trust fund that is unallocated. Our advisors would like us to meet certain measurements regarding the unallocated reserves, as calculated by our actuary.

Be a careful health consumer. The best way to increase the reserve level is by having favorable claims experience. Favorable claims experience comes from taking care of ourselves and our families. Favorable claims experience comes from using the right resource at the right time. We can create an environment where money stays on the check by reducing the need to funnel increasing contributions into the health system by acting responsibly with respect to our health care.

Some additional changes to come. We are immediately beginning a review of all of our methods, definitions, processes and procedures with the Health Partners staff. We are hoping to identify new opportunities to implement "best practices" in providing health care to our members and their families.

I don't expect that we will be able to conquer health care inflation over night. I also don't expect that we will change over night any bad habits that we may have. But what I do expect is that the membership pays close attention to these issues, as they are critical to preventing further erosion of our standard of living as union members.

### **Unity Builds Greater Strength**

BAC Local 1 MN/ND Affiliates with St. Paul RLF

Working together makes us stronger. That's what unions are all about. And that's why Bricklayers Local 1 is affiliating with the Saint Paul Regional Labor Federation (RLF), AFL-CIO.

As the East Metro's central labor body, the Saint Paul RLF connects 100-plus affiliate unions and more than 50,000 union members in Ramsey, Dakota, Washington and Chisago counties. Together they form a powerful network of union activists and volunteers who work to create good jobs and strengthen their communities.

Building trades unions have long been a key part of making the RLF a strong voice for working families in the East Metro. Under the leadership of President Bobby Kasper, the federation has stepped up its involvement in local elections and campaigns, building the relationships necessary to ensure economic development and public investments to create jobs that meet area wage and benefit standards.

RLF mobilizes union volunteers in support of candidates on the local, state and federal levels who understand the importance of investing in our public infrastructure, and who support prevailing-wage laws that keep our communities strong.

In 2015, for example, the federation provided assistance to a successful levy campaign in the Forest Lake school district. Two months after voters approved \$140 million in capital improvements, the school board voted unanimously in favor of entering into a Project Labor Agreement covering the work.

"Elections are critical to the future of our unions, especially

in a year like 2016," Kasper said. "In the last five years, Minnesota has become an oasis of union strength surrounded by Right to Work states."

Getting members involved with elections and organizing is a key role of the RLF, and efforts are in the works to get volunteers from unions' apprenticeship programs.

"The Regional Labor Federation works hard every day to protect the professional standards, rights and quality of life Minnesota's union members enjoy, but the only way we're going to be successful is if we work together," Kasper said.

The RLF also sustains a tradition of giving back to communities through its non-profit arm, the St. Paul Labor Studies and Resource Center. Annual initiatives include a school-supply drive in Dakota County, fundraising for United Way's metro campaign and a winter-clothing drive that last year provided \$2,250 worth of coats and hats to homeless students.

From community-service projects to political campaigning, the RLF draws its strength and its direction from a growing network of volunteers active in labor assemblies based in each of the federation's four counties of jurisdiction.

In 2008 approximately 57 percent of the voting-age population cast a vote. In 2016, 55 percent showed up at the polls. This year we'll elect a new president and vice president of the United States. Many states will also have congressional and state legislative seats up for election. Your vote is important. It does make a difference.

**Now** is the time to take an active role in the political process by becoming aware of where candidates stand on important issues that affect you and your family. Issues such as health care, employment and job growth, student loan refinancing, homeland security, gun control, tax reform and protecting social security are among many issues which continue to be discussed within all levels of government. Do you know who is best qualified to represent your beliefs and values on these topics? Log onto the candidates' websites to gain greater insight on who deserves your vote.

Make sure you are registered to vote. Same day voter registration is NOT available in all states. If you choose to vote by absentee ballot, you will need to submit an application for one. US based voters, overseas citizen voters and US military voters can find comprehensive information on these subjects at www.usvotefoundation.org.

Take your school-aged children with you on November 8 so they can observe the political voting process in action. Encourage them to become active citizens within their community, laying the groundwork for when they reach voting age.



# **Three Ways that IMI Works for YOU!**

Three ways that IMI works for BAC members is by providing technical assistance, continuing education, and craftworker training. IMI Director Mark Swanson also generates BAC Local 1 MN-ND job opportunities by being a masonry resource to the design and construction community.

#### 1) Technical Assistance

IMI Director Mark Swanson provides technical assistance to signatory contractors as well as architects and engineers on a weekly basis. One of the most often asked questions from architects is where to locate movement joints in masonry. Other inquires include: architects asking how to detail flashing on a stone base, engineers asking




#### 2) Continuing Education

IMI is a continuing education provider for the American Institute of Architects (AIA) and reports these hours online to AIA. Licensed engineers and architects are all required by the state to continue their education and must submit documentation to the state that they have done so. IMI and the Minnesota Structural Masonry Coalition have hosted several continuing education seminars to structural engineers and architectural firms. # Another attack on Labor

It's a new year and it unfortunately means another new attack on working people. In January, the United States Supreme Court heard arguments on a case called Friedrichs v. California Teachers Association (CTA). The lawsuit challenges the authority of CTA and other public-sector employee unions to collect fair-share fees from all employees they are legally required to represent. Plain and simple; this is an attempt to weaken unions and workers' voices.

Nobody is ever forced to join a union, but states like Minnesota allow unions to charge non-members fees to cover the costs of representation and bargaining. If the court rules against the union, the entire public sector would be in a so-called "Right to Work" environment. That means non-members would get all the benefits of a union contract without having to pay dues. That's not fair.

While an unfavorable ruling wouldn't directly impact private sector unions, we know from experience that special interests won't stop with the public sector. In 2011, Wisconsin Governor Scott Walker signed legislation severely weakening public sector unions' ability to negotiate and raise resources. Four years later, Walker was signing a bill making Wisconsin a "Right to Work" state.

Finally, it's important to remember that 2016 is an election year. While the race for president might be grabbing the headlines right now, we should also be taking a closer look at our congressional and state legislative races. This year, every Minnesota House and Senate seat is up for election. It is crucial that we keep a pro-Labor majority in the Senate and regain the majority in the House. It's a clear choice. If we elect majorities to the House and Senate, we can keep building a better Minnesota. If we lose majorities, we will find ourselves facing Wisconsin-style attacks on our rights and livelihoods.

Right now, your union, Area Labor Council, and State Federation are researching and screening candidates



for endorsement. If a candidate is Labor-endorsed, it means that person is committed to protecting our rights and improving the lives of working people. It's going to take all of us working together to win this fall; knocking on doors, making phone calls, and talking at the worksite.

We can win, because we are stronger together.
