This is to advise you that the new working agreement calls for a \$2.00 increase per hour on May 1, 2019. Please inform your bookkeeping department of the following rates.

SWING PAY – There will be no premium pay for Swing Scaffold work.

PARKING – Employees shall be reimbursed \$8.00 per day in downtown Minneapolis & St. Paul and the U of M St. Paul & Minneapolis campuses. ***Parking receipt is required***

***MASONRY INDUSTRY ADVANCEMENT FUND (MIAF) & MINNESOTA CONSTRUCTION INDUSTRY WORKFORCE ALLIANCE (MCIWA)** – Employers will submit an additional \$.15 per hour to the MIAF and \$.01 to MCIWA. **These employer contributions will not affect the 1% increase and are not considered part of the wage.**
